

*Government Notice No. 65 of 2012***THE LOCAL GOVERNMENT ACT 1989****Regulations made by the Municipal Council of
Quatre Bornes under sections 50, 158 and 163 of the
Local Government Act 2011**

1. These Regulations may be cited as the Municipal Council of Quatre Bornes (Crematorium) Regulations 2012.

2. In these Regulations:–

“applicant” means any person who satisfies the Council that he is authorized by the deceased’s next-of-kin to cause the corpse to be cremated at the crematorium;

“corpse” means the deceased’s body, human corpse or remains thereof, which is meant to be cremated;

“Council” means the Municipal Council of Quatre Bornes;

“cremation” has the same meaning as in the Public Health Act;

“cremation permit” means the permit issued under the Public Health Act, in respect of the deceased, by the Sanitary Authority;

“crematorium” means the crematorium at the Palma Cremation ground or such other place as may be constructed, managed and maintained by the Council;

“death certificate” in respect of the deceased, has the same meaning as in the Public Health Act;

“officer” means an officer of the Council or any person designated by the Municipal Council of Quatre Bornes;

“Sanitary Authority” has the same meaning as in the Public Health Act.

3. The Applicant shall apply for the cremation permit in the form set out in the Schedule I to these regulations, and shall at the time of the application, furnish to the Council the originals, or true certified copies, of the death certificate and the cremation permit respectively.
 4. The Council may, upon receipt of the application, and upon payment of the appropriate fee, set out in Schedule II allow thereto access to the Applicant on such day, at such time, and under such conditions, as it deems fit, for the purposes of the cremation.
 5. The Applicant shall, at his own costs, cause the corpse to be delivered at the time appointed by the Council. The Council may, upon the Applicant's failure to deliver the corpses in time, postpone the cremation to such date and time as it deems fit, in which case the Applicant shall be responsible for the keeping of the corpse.
 6. The Council shall not be responsible for any incomplete or unsatisfactory combustion of the corpse, resulting from the failure in power supply, or the breakdown or any of the equipment associated with the cremation process.
 7. The Applicant shall, within 48 hours of the cremation, collect the cremation remains or ash, in an urn provided by the Council, failing which the Council shall dispose of the said remains and ash, in such manner as it deems fit.
 8. In the event the cremation is frustrated, the Council will arrange for the cremation without any additional charges.
 9. The time of operation of the crematorium shall be from 09.00 a.m. to 04.30 p.m., with at least one and a half hour interval except in exceptional circumstances as may be authorised by the Chief Executive

10. Any person who:

- (lxvi) gives false particulars at time of the application;
- (lxvii) uses foul language at the crematorium;
- (lxviii) creates disorder at the crematorium;
- (lxix) does not comply with an order of the Officer at the crematorium;

shall commit an offence, and shall on conviction be liable to a fine not exceeding twenty five thousand rupees (Rs 25,000).

11. The Municipal Council of Quatre Bornes (Crematorium) Regulation 2011, G.N 79 of 2001 is repealed.

12. The Regulations shall come in force on its date of publication.
